On Film 1972. Commencing on Page 1124, covering the following described real property, to wit:

Country Walk Third Estates Mulyane, Sedgwick County, Kansas

The above described property being hereinafter referred to as the "Original Property" or the "Property".

Whereas, Section 16.02 of Article XV of the Declaration authorizes the Declarant to amend the Declaration, upon the affirmative vote of seventy-five percent (75%) of the votes of the Class A Members of the Association, and

- 1. Whereas, Declarant desires to and does hereby amend the Declaration to replace the following paragraph 16.02 of Article XV of the Declaration.
 - 16.02 Other Amendment. After Declarant owns no lot in the property, these Covenants maybe amended only upon the affirmative vote of fifty percent plus one (50% + 1) of the tallied votes of the Class A Members of the Association, in person or by proxy at a meeting called for such purpose, evidenced by an Amendment to the Declaration duly executed and acknowledge by such Class A Members and recorded in the office of the Register of Deeds of Sedgwick County, Kansas.
- Declarant hereby certifies that this Amendment has been executed in accordance with Section 16.02 of the Declaration and is in effect and valid in pursuant to all terms and provisions of the Declaration.
